WHAT WE DO

Friends of the Pound specialise in the care, shelter, and rehoming of cats and dogs. We work closely with the Tweed Shire Pound, providing care and support for stray animals during their impound period and preventing unnecessary euthanasia by rehoming them and giving them a second chance at life.

Animals available for adoption may be viewed at our Rehoming Centre (located at the Tweed Shire Pound), or by appointment at individual foster care homes. We also operate a Rehoming Booth inside the Tweed Heads South Petbarn.

Friends of the Pound also help to promote the importance of responsible pet ownership throughout the community and aim to lessen the increasing number of homeless animals, particularly through encouraging the desexing of animals.

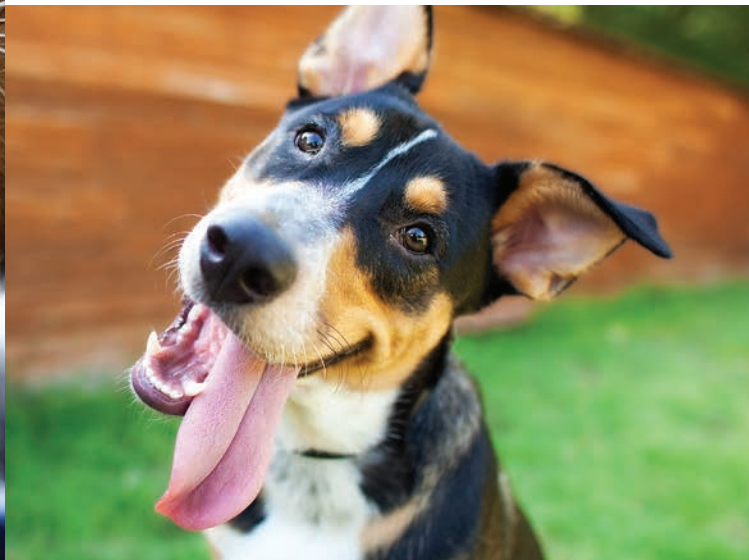
In the event that you need to part with your pet due to unforeseen circumstances, we can ensure your pet is suitably rehomed and lovingly cared for.

CONDITIONAL BEQUEST (EXAMPLE)

"I give the sum of \$_____ to Friends of the Pound (Tweed) Inc ABN 83126970338 of PO Box 164, Banora Point NSW 2486 Australia, for the purpose of ensuring that my pet _____ is suitably rehomed and direct Friends of the Pound (Tweed) Inc to pay for any necessary veterinary treatment to the amount of this bequest until my pet dies from natural causes or his/her vet recommends euthanasia.

This bequest shall be free of all duties, and I declare that a receipt from the Secretary or administrator of that Organisation shall be sufficient discharge and my Trustee shall not be bound to see to the application thereof".

The above text contains suggested wording, however Friends of the Pound recommend that you consult your solicitor and inform your Power of Attorney if you include a bequest to them in your will.
