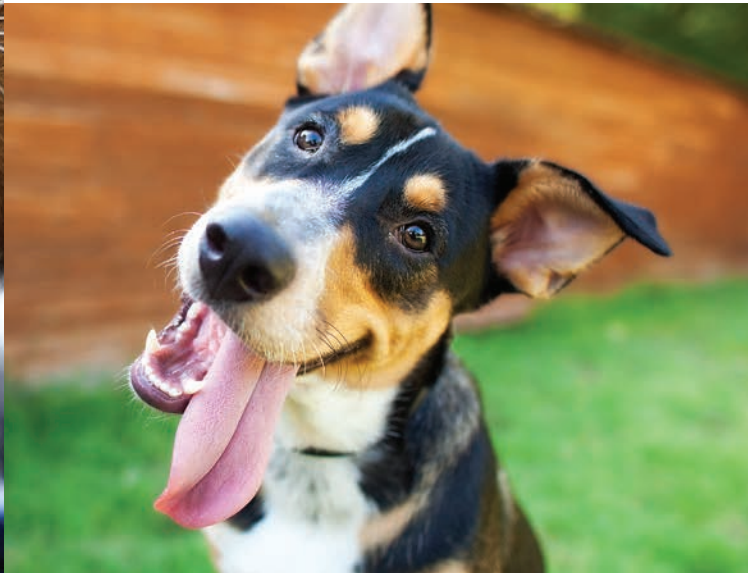
In the event that you need to part with your pet due to unforeseen circumstances, we can ensure your pet is suitably rehomed and lovingly cared for.

CONDITIONAL BEQUEST (EXAMPLE)

"I give the sum of \$_____ to Friends of the Pound (Tweed) Inc ABN 83126970338 of PO Box 164, Banora Point NSW 2486 Australia, for the purpose of ensuring that my pet _____ is suitably rehomed and direct Friends of the Pound (Tweed) Inc to pay for any necessary veterinary treatment to the amount of this bequest until my pet dies from natural causes or his/her vet recommends euthanasia.

This bequest shall be free of all duties, and I declare that a receipt from the Secretary or administrator of that Organisation shall be sufficient discharge and my Trustee shall not be bound to see to the application thereof".

The above text contains suggested wording, however Friends of the Pound recommend that you consult your solicitor and inform your Power of Attorney if you include a bequest to them in your will.
